Sláintecare supported by Digital for Care




Sláintecare is the underpinning 10-year strategy for the health service and has identified an electronic health record as essential to truly deliver integrated care.

Integrated care is core to the Sláintecare strategy and dependent on connected data flow to allow the delivery of the right care, in the right place, at the right time, by the right team.

'Digital for Care' is the government approved digital strategy for the Irish health service. This includes a commitment to implement a National Electronic Health Record (EHR) to deliver the Sláintecare objective of integrated care.

6 Principles of Digital for Care Strategy





Digital Healthcare – Case for Change



There are a number of key drivers of change.

- Sláintecare and Health System Reform: A requirement to support significant reform of the health system supported by digital transformation
 - Health Service Demands: Increasing pressures on the health service as a result of increasing complexity of care, increasing demands for care and challenges with recruitment and retention of staff.
 - Integrated Care: Requirement to deliver integrated rather than episodic care
 - Patient Expectations: Evolving patient expectations and personalised patient care
 - **Increasing regulations and cybersecurity requirements:** This includes the European Health Data Space, EU Data Act and NIS2 regulations
 - Rationalise current technology: Need to rationalise the current health service application ecosystem which includes many thousands of clinical, operational and support systems
 - **Manual processes and functionality gaps:** Requirement to digitise current manual and paper-based processes such as prescribing and clinical notes

Co-Designing the National Digital Patient Panel

Building on the insights and experiences shared from current patient partners our next step is to **co-design a national framework** that ensures consistency, clarity, and meaningful involvement for patient partners across all digital health initiatives.

We will work together to:

- Continue meaningful engagement
- Standardise roles and responsibilities
- Create a national Patient Peer network
- Define a consistent approach
- Ensure equitable access to information
- Embed the patient voice at the heart

This next phase is not just about structure—it's about **co-creating a panel that works for patients**, enabling real partnership and impact in shaping the future of digital health across the HSE
